## AUDIT RISK AND IMPROVEMENT COMMITTEE

Council is seeking to appoint a minimum of two external members including a Chairperson to its Audit Risk and Improvement Committee. The Audit Risk and Improvement Committee is an independent advisory committee to Council whose role is to monitor, review and advise Council on matters of accountability and internal control affecting the operations of Council. The Committee will consist of a minimum of two (2) external members (one of whom will be the Chairperson) and one Councillor. The Committee will meet at least three times a year.

Applications are now being sought from interested persons with appropriate qualifications, skills and expertise wishing to serve on or Chair this Committee. The appointment will be for an initial term of three (3) years. A sitting fee will be paid to external members of the committee.
