WASTE SERVICES CHRISTMAS/NEW YEAR

Federation Council is pleased to advise it has taken extra steps to manage the influx of waste generated over the busy Christmas and New Year period.

Council will provide skip bins at the Mulwala Waste Facility from Monday 23 December 2019 to the end of January 2020 as an additional service. The facility is located at Barooga Road, Mulwala and access to the skip bins will be available 24 hours a day until the end of January.

The Oaklands and Urana Waste Facility opening hours will be changing effective Wednesday 18 December on a 3 month trial basis. The Oaklands facility will close on Tuesdays and Urana will close on Fridays with both facilities open on a Sunday as per normal operating hours. Residents and visitors can dispose of waste at the skip bins available in Urana at the Victoria Park Recreation ground and at Oaklands on the corner of Thompson and Gunambil Street behind the Oaklands Recreation Reserve.

The Corowa and Howlong Waste Facilities will be operating as per normal hours over the Christmas and New Year period.

Bins that are located in Council public parks and gardens will be emptied daily over the Christmas and New Year period.

The kerbside bin collection dates for all towns will be as usual over the Christmas and New Year period with residents reminded to place their bins out for collection.
