

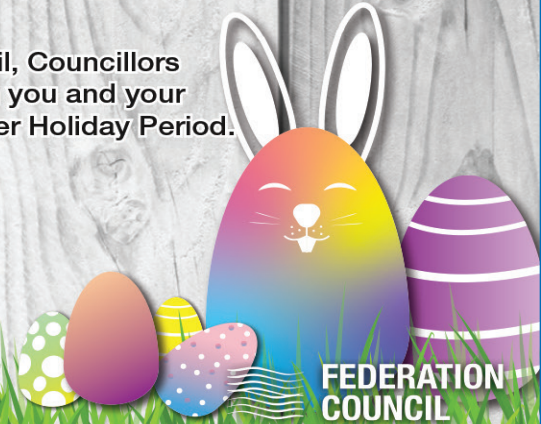

Following recent toilet paper shortages, our staff have seen an increase in wipes and other items being disposed of down the toilet.
