COUNCIL COMPLIANCE NOTIFICATIONS FOR COMPANION **ANIMALS**

RESPONSIBILITIES OF PET OWNERS

If your dog is in a public place it must be under the effective control of a competent person by means of an adequate chain, cord or leash. The exceptions to this are:

- · Dogs exhibited at a show or engaging in obedience or agility trials or a dog secured in a cage or vehicle or in an approved off leash area.
- If your dog is being exercised in an approved off-leash area it must always be under effective control of a competent person.
- You are not permitted to walk more than four dogs at any one time in an on-leash or off-leash area. · Greyhounds must be muzzled at all times when in a
- public place.
- If your dog defecates in a public place it is an offence not to remove the faeces.
- Dogs are prohibited in children's play areas, food preparation/consumption areas, reception areas, public bathing areas, school grounds, child care centres, shopping areas and wildlife protection areas.

MICROCHIPPING AND REGISTRATION

Microchipping and registration is a two part process that requires dog and cat owners to:

- 1. Have their dog or cat implanted with a microchip from the time they are 12 weeks of age, at point of sale or change of ownership (whichever occurs first).
- 2. Register their animals with their NSW local Council by 6 months of age.

Both the microchipping and registration of your dog or cat include a one-off fee and are for the life of the animal.

FEDERATION COUNCIL APPROVED OFF-LEASH **AREAS**

The purpose of leash free areas is to allow dogs to exercise off lead, to run freely in a safe environment, to enjoy off lead activities without interfering with the general public and to provide the opportunity for socialising with other dogs.

Federation Council has provided four off-leash areas in the Council area:

Corowa - Intersection of Federation Avenue and River Street South Corowa:

Eastern end of Edward Street opposite Bangerang Park, adjacent to tennis courts

Mulwala - Kyffins Reserve, 4.1km east of Mulwala, Spring

Howlong - South west corner of Lowe Square
