COUNCIL COMPLIANCE NOTIFICATIONS FOR COMPANION ANIMALS

RESPONSIBILITIES OF PET OWNERS

If your dog is in a public place it must be under the effective control of a competent person by means of an adequate chain, cord or leash. The exceptions to this are:

- Dogs exhibited at a show or engaging in obedience or agility trials or a dog secured in a cage or vehicle or in an approved off leash area.
- If your dog is being exercised in an approved off-leash area it must always be under effective control of a competent person.
- You are not permitted to walk more than four dogs at any one time in an on-leash or off-leash area.
- Greyhounds must be muzzled at all times when in a public place.
- If your dog defecates in a public place it is an offence not to remove the faeces.
- Dogs are prohibited in children's play areas, food preparation/consumption areas, reception areas, public bathing areas, school grounds, child care centres, shopping areas and wildlife protection areas.

MICROCHIPPING AND REGISTRATION

Microchipping and registration is a two part process that requires dog and cat owners to:

1. Have their dog or cat implanted with a microchip from the time they are 12 weeks of age, at point of sale or change of ownership (whichever occurs first).
2. Register their animals with their NSW local Council by 6 months of age.

Both the microchipping and registration of your dog or cat include a one-off fee and are for the life of the animal.

FEDERATION COUNCIL APPROVED OFF-LEASH AREAS

The purpose of leash free areas is to allow dogs to exercise off lead, to run freely in a safe environment, to enjoy off lead activities without interfering with the general public and to provide the opportunity for socialising with other dogs.

Federation Council has provided four off-leash areas in the Council area:

Corowa - Intersection of Federation Avenue and River Street, South Corowa;
Eastern end of Edward Street opposite Bangerang Park, adjacent to tennis courts

Mulwala - Kyffins Reserve, 4.1km east of Mulwala, Spring Drive

Howlong - South west corner of Lowe Square
