COMPLETION OF GRAY STREET WORKS IN COROWA

Council staff and local residents gathered on 1 May 2017 to officially 'reopen' Gray Street in Corowa following extensive redevelopment works.

The total cost of the works was \$220,000 and included;

- · Widening of the road
- · Installation of kerb and guttering and
- · Lowering of the road to accommodate storm water drainage
- · Resurfacing of the road

Where practical, Council is endeavouring to take a 'whole of street' approach when completing works in urban areas. In some cases, it is possible to program kerb and guttering, underground storm-water, footpaths and even water and sewer mains into the one job if they are required.

This prevents Council having to come back and disturb neighbourhoods too many times, and allows for a street to look truly finished by even seeding the lawn nature strips.

Council thanks residents for their patience throughout the duration of the works.



DRAFT DISABILITY INCLUSION ACTION PLAN

As part of the NSW Disability Inclusion Act, all NSW Councils are required to develop a Disability Inclusion Action Plan to help remove barriers and enable people with a disability to participate fully in their communities.

Federation Council endorsed its draft Disability Inclusion Action Plan at the April Council meeting and has placed the document on public exhibition to seek feedback from the community.

Council's Disability Inclusion Action Plan aims to:

- promote positive attitudes and behaviours in the community
- provide better access to information, services and facilities
- provide a more liveable and accessible community
- enhance employment opportunities and
- increase opportunities for people with disability to participate.

FIRE AND EMERGENCY SERVICES LEVY

From 1 July 2017, the NSW Government is introducing a fairer system for funding our community's fire and emergency services. At present, these services are funded by a levy on insurance, which will be removed from 1 July. From this time, all properties, not just insured properties, will directly contribute to the cost of these services through the Fire and Emergency Services Levy (FESL).

The FESL will be paid alongside your council rates. You will be notified in July of your FESL contribution as part of your council rates notice, or a separate notice for non-rateable properties. Like council rates, you may pay the FESL annually or quarterly.

The FESL paid will, in part, depend on your properties classification as a residential, farmland, industrial, commercial or public benefit, and whether or not the land is vacant.

Residents are now receiving a letter from council with their properties classification. No action will be required if you agree with the classification of your property.

If you disagree with your properties classification, you can request a review by contacting Federation Council on (02) 6033 8970 or **rates@federationcouncil.nsw.gov. au** and completing the FESL – Review Application Form available on council's website.
