# ANNUAL PERMITS FOR NON-DESEXED CATS AND DANGEROUS/RESTRICTED **DOGS**

From 1 July 2020 the NSW Government will introduce annual permits for owners of non-desexed cats, restricted dog breeds, and dogs declared to be dangerous.

This means that owners of cats not desexed by four months of age will be required to pay an \$80 annual permit in addition to their one-off lifetime pet registration fee. Owners of dogs of a restricted breed or declared to be dangerous will be required to pay a \$195 annual permit in addition to their one-off lifetime pet registration fee. This applies to dogs that are already registered.

Pet owners will be able to pay for annual permits using the online NSW Pet Registry, or from Council. Annual permits are not available from Service NSW.

#### PET OWNERSHIP RESPONSIBILITIES

Whether you consider yourself a dog person or a cat person, we all have a responsibility to our companion animals. Residents are reminded of the responsibilities of pet owners to ensure the safety of companion animals and the

If your dog is in a public place it must be under the effective control of a competent person by means of an adequate chain, cord or leash. The exceptions to this are dogs exhibited at a show or engaging in obedience or agility trials or a dog secured in a cage or vehicle or in an approved off leash area.

If your dog is being exercised in an approved off-leash area it must always be under effective control of a competent

You are not permitted to walk more than four dogs at any one time in an on-leash or off-leash area.

If your dog defecates in a public place it is an offence not to remove the faeces.

Dogs are prohibited in children's play areas, food preparation/consumption areas, reception areas, public bathing areas, school grounds, child care centres, shopping areas and wildlife protection areas Find out more from Council's website.

# **OFF LEASH AREAS**

Federation Council provides designated off-leash areas to allow dogs to exercise off lead, to run freely in a safe environment, to enjoy off lead activities without interfering with the general public and to provide the opportunity for socialising with other dogs.
