FLOODPLAIN MANAGEMENT PROJECTS

Federation Council has been successful in obtaining NSW State Government Floodplain Management grant funding to undertake four projects recommended by the 2022 Federation Villages Floodplain Risk Management Study and Plan. These four projects include a:

- Urana Levee Upgrade Design,
- Morundah Flood Mitigation Design,
- Federation Villages Flood Warning System, and
- Boree Creek Voluntary House Raising and Voluntary Purchase Scoping Study.

All four projects have recently commenced. Residents are encouraged to view details of the four projects from Council's website.

COMMUNITY MEETING - BOREE CREEK - VOLUNTARY HOUSE RAISING AND PURCHASE SCOPING STUDY PROJECT

A community information meeting is to be held at the Boree Creek Memorial Hall on **Wednesday 23 August**, commencing at 4.30pm. The meeting is expected to take between 1 and 2 hours.

The information meeting follows the recent commencement of a Voluntary House Raising (VHR) and Voluntary Purchase (VP) project for Boree Creek. The project is being undertaken by Federation Council. It follows Council obtaining NSW State Government funding to assist with the implementation of the Federation Villages Floodplain Risk Management Study and Plan, which was finalized by Council in 2022.

ON EXHIBITION - NEW FEES & CHARGES - UNDERGROUND PETROLEUM STORAGE SYSTEMS

Council reviewed and endorsed the new fees and charges for Underground Petroleum Storage Systems at its July ordinary Meeting for public exhibition for a period of 28 days.

Underground petroleum storage systems (UPSS) sites are highly regulated in NSW given their risk of leaks and contamination. From Friday 1 September 2019 State Government delegated responsibility of regulating most sites to local governments.

New Fees & Charges

- \$175.00 for Council staff to undertake a routine inspection of a UPSS site; and
- \$120.00 for Council staff to undertake a reinspection of a UPSS site.

EXPRESSION OF INTEREST

Federation Council has recently initiated a project to prepare detailed designs for an upgrade of the existing flood protection levee bank at Urana township. The detailed design of the levee is being undertaken by consultants Dryside Engineering for Council. As part of the levee design project, Council is inviting Expressions of Interest from local landholders for potential borrow pit sites which contain material with a high clay content. Borrow pits found to contain suitable material could be used to source material for the levee construction. An estimated 25,000 to 30,000 cubic metres of material will be required. Round one of the Federation Council 2023-2024 Community Grants Program is now open, with funds available to help local community groups, organisations and clubs to deliver a range of community projects and events.

- Category 1 – Seed funding grant; to support the establishment of new initiatives, applicable up to \$3,000 per applicant.

- Category 3 – Community events grant; to support the strategic development for small to medium events, applicable up to \$1,500 per applicant.

ON EXHIBITION - DRAFT MODEL CONTAMINATED LAND POLICY

At Council's July ordinary meeting it endorsed the draft Riverina & Murray Joint Organisation (RAMJO) and Riverina Eastern Regional Organisation of Councils (REROC) Model Contaminated Land Policy for public exhibition for a period of 28 days.

The draft policy outlines Council's commitment in regard to managing contaminated land in its local government area. It also provides information to internal and external stakeholders, interested parties and the broader community on Councils position on managing contaminated land and is applicable to staff involved in Council land-use planning and development control functions, as well as in waste management in managing public and Council assets.
