3.	Payment of all applicable contributions and levies must be completed before Council will issue a Section 307 Certificate under the <i>Water Management Act</i> , and confirmation of payment of applicable levies under Section 7.12 of the <i>Environmental Planning and Assessment Act</i> 1979.
