NEW FOOD SAFETY REQUIREMENTS APPLY SOON

There are just weeks remaining for local school canteens, childcare centres, supermarkets, coffee vendors selling food, and boarding schools to prepare for a new food safety standard enforceable in NSW from 8 December 2024.

The standard introduces three new requirements for businesses depending on their food handling activities: Appointing a Food Safety Supervisor, ensuring food handlers are trained, and being able to show safe food practices. The national standard applied to most food businesses from 8 December 2023 however some business types in NSW received a further 12 months to comply.
