## LAKE MULWALA LOWERING

The Murray-Darling Basin Authority has advised that the water level in Lake Mulwala will be gradually lowered by 1.5 metres for maintenance works on the weir and bridge.

• When: The water will recede gradually over the next 5 weeks.

· Why: Essential maintenance on Yarrawonga Weir and Mulwala Bridge.

Please note this is NOT a full drawdown of Lake Mulwala like in 2022. Once all work is complete the lake will be refilled ahead of the next irrigation season. This work is done in collaboration with Goulburn-Murray Water and Transport for NSW.

Boat ramps and access points may be affected, and water users are requested to always check conditions.
