## **NEW FOOD SAFETY REQUIREMENTS APPLY SOON**

There are just weeks remaining for local school canteens, childcare centres, supermarkets, coffee vendors selling food, and boarding schools to prepare for a new food safety standard enforceable in NSW from 8 December 2024.

The standard introduces three new requirements for businesses depending on their food handling activities: Appointing a Food Safety Supervisor, ensuring food handlers are trained, and being able to show safe food practices. The national standard applied to most food businesses from 8 December 2023 however some business types in NSW received a further 12 months to comply. Federation Council advises that there are significant delays to all applications being lodged for each stage of the development process. Staff shortages, in conjunction with the increasing complexity of the NSW Planning Portal Processes required to be undertaken by Council has seen pre-lodgement assessment times increasing to 6-8 weeks and average determination times taking between 10-12 weeks. We ask you for your cooperation as Council officers concentrate on clearing the backlog of applications while maintaining all other legislated services

## **RESPONSIBILITIES OF PET OWNERSHIP**

Being a pet owner means there are responsibilities by law that are required to be adhered to.

Over the last few months, Council has received an increasing number of complaints in relation to aggressive dog behaviour and dogs escaping property and roaming the streets. To ensure the safety of your pet and the community, residents are reminded of some of the responsibilities of pet ownership to ensure your pet lives a full and happy life in our community:

- Provide a secure home environment so your dog cannot escape.
- Registration. Microchipping.
- Wearing a collar and identification tag with the name of the dog or cat, address or telephone number of the owner when in a public place.
- If you have moved residences, updating your contact details on your pet registration and microchipping records.
- When you take your dog to a public place they must be under the owners' effective control. This means on an adequate leash, chain or cord. If your dog is in an off leash area, it must be under your effective control.

Stray dog sightings should be reported to Council. If you find a stray or lost animal please contact Council and a ranger will collect the animal from you. During business hours, please call us or after hours complete our online customer request form: (add link to customer request form) Our furry friends are so important in our lives and at Council, there is

no better joy for our rangers to be able to return your pet home safely, however, if the above items are not followed we may not know where to return it to. Find out more from Council's website.
